6. Responsibilities of the Committee

- Ensure strict compliance with PCI anti-ragging norms
- Conduct awareness programs and orientation for students
- Display anti-ragging posters and helpline numbers
- Maintain discipline in campus and hostels
- Take immediate action on complaints
- Submit reports to PCI/University as required

7. Preventive Measures (Mandatory as per PCI)

- Submission of Anti-Ragging Affidavit by students and parents
- Display of Anti-Ragging Warning Boards
- Installation of CCTV cameras in sensitive areas
- Regular interaction between seniors and juniors under supervision
- Monitoring of hostels and transport facilities

8. Punishment for Ragging (As per PCI/UGC Norms)

- Depending upon the severity:
- Suspension from classes
- Debarment from examinations
- Rustication/expulsion from institution
- Cancellation of admission
- Withholding scholarships
- Filing of FIR with police authorities
